Stolen Generations is the name given to at least 100,000 Aboriginal and Torres Strait Islander children who were removed from their families. This occurred in the ACT (1999), Tasmania (2000) and Western Australia (2006). The Separation of Aboriginal and Torres Strait Islander Children from their Families Act 1957, which came into effect on May 20, 1957, was the primary legislation in Queensland and Western Australia. In New South Wales, after 1940, the removal of Indigenous children was also based on this legislation. The total number of Indigenous children removed from their families in the name of assimilation is estimated to be around 100,000. The overwhelming majority of these children were removed from their families in the name of assimilation. The separation experienced by these children is a central theme of the Stolen Generations.
